The Advisory Committee on Immunization Practices (ACIP) released their updated **immunization schedules and most current recommendations**.

Vaccine Information Statements (VIS) It's federal law!

All vaccine providers, public or private, are required by the **National Childhood Vaccine Injury Act** to give the appropriate **Vaccine Information Statements (VIS)** to the patient (or parent or legal representative) before every dose of specific vaccines.¹

You are required to record the following information in your patients' medical records:

- VIS edition date
- Office address, name and title of the person who administered the vaccine
- Date the VIS is provided (a VIS must be provided before a vaccine is administered)
- Date the vaccine is administered
- Vaccine manufacturer and lot number
